## I. CALL TO ORDER / APPROVAL OF MINUTES

#### II. ANNOUNCEMENTS

### Dr. Kevin A. Morano, Associate VP for Faculty Affairs & Development

Dr. Morano provided his info as follows:

- The Graduate School of Biomedical Sciences Dean search is expected to kick off on March 2 with an announcement at the faculty meeting.
- An announcement of the Dean of McGovern Medical School is expected in the near future.
- Dr. Morano provided an update on local COVID-19 test positivity. Rates are falling quickly and expected
  to continue to drop in the coming weeks. Dr. Morano advised the committee to watch for directions from
  leadership regarding ongoing safety measures.

#### Dr. Elaheh Ashtari, Diversity, Equity, and Inclusion Council:

- The Diversity, Equity, and Inclusion Council is in its inaugural year and is thus discussing Council plans, goals, and recruitment strategies.
- The Council is working on educational modules to provide current diversity, equity, and inclusion training to Council members to ensure consistency in messaging across Council initiatives.
- The Council has identified LGBTQ+-related learning modules on LinkedIn to provide training to individuals
  interested in being identified as allies by the University. The ally program is anticipated to go live in June
  2022.
- The Council is working on identifying a Council member to join the HOOP Policy Council to provide guidance on Diversity, Equity, and Inclusion language.
- Dr. Ashtari requested that any Diversity events be sent to Dr. Asia McCleary-Gaddy to be included in the Office of Diversity and Inclusion calendar.

### III. NEW BUSINESS

#### **UTHealth Media Relations**

Dr. Jeter welcomed Ms. Meredith Raine, Ms. Deborah Lake, and Ms. Lauren Mathews to the IFC's Meeting. In preparation for this meeting, Dr. Jeter provided our guests with a selection of questions to consider addressing with the membership.

Ms. Meredith Raine introduced Ms. Deborah Lake as the Director of UTHealth Houston Media Relations. Ms. Lake began with a discussion of the role of Media Relations at UTHealth Houston, indicating that Media Relations is responsible for managing the University and its faculty and staff with media outlets. She discussed the "beat system" structure of Media Relations and provided information on how to find the appropriate Media Relations contact for each "beat," or area, within the University. Ms. Lake discussed the importance of including Media Relations in any and all communication with the media to control messaging from the University and manage the University's reputation. Ms. Lake concluded with a discussion regarding the role of faculty specialists and the requirements to become a faculty specialist (i.e., availability on short notice, responsiveness to requests). In response to a question from Dr. Kasper, Ms. Lake discussed available training opportunities related to media interactions.

Following Ms. Lake's presentation, Ms. Raine introduced Ms. Lauren Mathews as the Director of Branding and Creative Services. Ms. Mathews opened with a discussion of the new UTHealth Houston logos and branding initiatives, including presentation of the John S. Dunn Behavioral Sciences Center, Cizik School of Nursing, and a campaign at Houston Hobby airport for the holidays in 2022. Ms. Mathews directed attendees to http://www.uth.edu/brand-standards for current information regarding branding and to find assets related to presentations and poster templates, among other branded items. She discussed upcoming fiftieth-anniversary events. Following her presentation, she took a question about social media training, to which Ms. Raine answered that Media Relations can be contacted for specific questions about best practices and that some further resources are forthcoming on the Media Relations website in regards to social media.

The pool allows for leave donation for employee use in instances not covered by the existing sick leave pool. In response to attendee questions, Ms. Hinojosa clarified that leaves continue to be funded by the same funding source paying each employee's salary.

## **Cizik School of Nursing Highlights**

Dr. Mackavey gave a presentation about the Cizik School of Nursing, including the following highlights. A copy of the presentation is attached and made a part of these minutes.

- There are 180 full-tuition scholarships provided by the PARTNERS organization.
- Cizik School of Nursing has 1,400 students.
- Postdoctoral and post-master graduate training opportunities are expanding, including new specialty concentrations that are under development.
- The nursing simulation lab was recently renovated.

## **Cizik School of Nursing**

- Cizik School of Nursing is developing specialty concentration programs. The first two are almost ready to launch (Post-Graduate Certificate in Cardiovascular Health and Systems Management and Post Graduate Public Health Concentration), two to three didactic courses, and three hundred hours of clinical rotations. Other concentrations include Endocrine with a diabetes focus.
- On February 1, the Cizik School of Nursing celebrated Chinese New Year.
- The School is also celebrating Black History Month by highlighting some School employees.

#### **Graduate School of Biomedical Science**

GSBS Researchers investigating new procedures for monitoring strokes:

- Dr. Muhammed Haque, Assisting Professor of Neurology at McGovern Medical School, is leading a study
  focused on determining whether MRI scans can be used to measure the extent to which the stroke-causing
  hematoma formed in a person's brain due to intracerebral hemorrhage is expanding, i.e., whether the pooled
  blood in the brain is fully clotted or only partially coagulated.
- This information can be used to determine whether or not surgical intervention is required to prevent further brain damage.

   This includes awards from NIH (PhD students Astrid Manuel, Ivan Coronado, Evan Yu, and Tasneem Kaochar),
   CPRIT (PhD students Surabhi Datta, Xinyuam Zhang, Fangfang Yan, Tavleen Singh, and Sarvesh Soni), and
   AHIMA (DHI student Mary Stanfill).
- Professor James Langabeer, PhD MBA, Associate Professor Tiffany Champagne-Langabeer, PhD, and Assistant
  Professor Andrea Yatsco, PhD earned a \$1.2 million grant award from the US Department of Justice. They will
  partner with the Houston Police Department to use the grant funds and assess the efficacy of integrating.


School of Dentistry Dr. Alan Myers


UTHealth School of Public Health Celebrates Black History Month
